1. The appointment of above candidate(s) shall take effect from the date of his/her joining at the ordered place of posting. He/She must report for joining at the ordered place of posting as soon as possible, but **not later than 7 days** from the date of issuance of this order, **failing which their candidature for the post is liable to be canceled.**
2. The appointment of above mentioned candidate(s) has/have been made on temporary basis and is subject to such terms and conditions of services as are applicable to similar class of employees and as laid down in ESIC (Staff & Conditions of Services) Regulations, 2023 as amended from time to time.
3. He/She will be on probation for a period of two years from the date of his/her joining and his/her services under the Corporation will be liable to be terminated during the temporary tenure by giving one month's notice in writing from either side.
4. He/She will be governed by the New Pension Scheme introduced with effect from 01.01.2004 as per Govt. of India, Ministry of Finance, Department of Expenditure OM No. A.40.11.01.99 dated 07.07.2004.
5. He/She will not be entitled for Travelling or any other allowance for joining the post.

6. His/Her appointment is subject to verification of his/her identity credentials, genuineness etc which will be conducted at later stage and in case, it is found that he/she is involved in any malpractices in the examination process, his/her appointment shall be summarily rejected and appropriate legal action shall be initiated against him/her.
7. **He/She will be posted for a minimum tenure of three years at the initial place of posting. No transfer request will be considered before completion of this tenure.**
