1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

2. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.

3. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. The buyers are advised to refer to the [OM_No.1_4_2021_PPD_dated_18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if the credentials of the service provider are validated on-line in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents.

4. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

5. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -

1. Three similar completed services costing not less than the amount equal to 40% (forty percent) of the estimated cost; or
2. Two similar completed services costing not less than the amount equal to 50% (fifty percent) of the estimated cost; or
3. One similar completed service costing not less than the amount equal to 80% (eighty percent) of the estimated cost.

1. Generic

OPTION CLAUSE 25% : The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, the contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration.

For lumpsum-based service contracts, the buyer may increase the scope of work and contract value up to 25 percent with the consent of the service provider

2. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

Service Provider:

The Service Provider is responsible to provide all the required services promptly to the satisfaction of the Buyer. The Service Provider may also include the seller, supplier/bidder/contractor, any authorized agents, permitted assignees, successors, and nominees as per the context and as described in the bid. The responsibilities and obligations of the stakeholders have been outlined in this document. The document also encompasses payment terms and deductions in case of non-adherence to the defined terms and conditions.

The scope of 'Supply of Water through Tanker' is to supply water from a Government-approved source in accordance with the location, quantity, and timing specified by the Buyer.

Terms and Conditions

1. Service provider to supply the water from Government approved source only, and the Service Provider shall produce the certificate in regards to the same to Buyer at any given point as requested by the Buyer.

2. Service Provider shall provide the Water Test Report as per frequency specified by the Buyer and the same must be from a NABL approved Lab only.

A) Chemical test of PH(6.5 to 8.5) , TDS >270 mg/lr, hardness, Chlorides ,sulphates , Fluoride.

B) Biological test of coliform test

i) Absence of Coliform bacteria & Escherichia coli

C) In case scope pertains to supply of drinking water, Service Provider to maintain ISO10500 standards for drinking water.

3. The Service Provider shall use only treated water as per the applicable rules/regulations/laws/guidelines/norms/ directions issued by the appropriate government.

4. Service Provider to maintain the quality of the water tanker to the satisfaction of the Buyer and shall strictly adhere to the Government specified norms.

5. While supplying water to Buyer site, Service Provider will comply with the time schedule given by the Buyer

6. Since water is an essential service, duty hours of tanker supply will be round the clock and across all the days of contract irrespective of any public/bank/festival holidays as per the requirement of the Buyer

7. The Service Provider shall maintain registers/logbook and checklists as per mutually agreed formats for every delivery of water tanker. This will include Total Dissolved Solids (TDS) reading and other basis quality parameters,

8. The Service Provider will always keep adequate number of equipment (in working conditions) along with the tankers to ensure pouring of water at the Buyer's premises.

9. Water tanker used by Service Provider must be equipped with working pump and GPS system at all time

10. Service Provider to provide access to the Buyer for tracking of the water tanker at any point of time

11. There will be no additional payment to Service Provider for water poured into tanks at ground/Underground level.

12. All safety accessories and measures as required for the execution of the work shall be provided to the workers by the Service Provider at their own cost.

13. Water tanker and its operations must comply to all the norms and guidelines by the RTO, MoRTH, State transport department & from other government organization as applicable.

14. Service Provider to maintain all the compliances issued by the Environment Ministry, Water Ministries, State Water departments, ULBs etc .

15. The Service Provider must leave work areas in a clean, tidy, and safe condition after completion

16. The Service Provider shall be liable for all surface and sub-surface pollution to the extent caused by Service Provider and resulting from his/her operation/service.

17. In case there are issues with the source of water such as problems related to pumping etc, it is the responsibility of the Service Provider to deliver water from alternative Government approved source. Service Provider shall take approval from Buyer while changing the source and there will be no extra cost paid to service provider for the same as applicable during the contract duration.

18. Service Provider shall have to keep the Buyer totally indemnified against all claims, damages, dues, payments, fines, penalties, compensation demands, liabilities and other losses, if any, that may arise on account of any non-compliance or violation of any contractual or statutory provisions by the Service Provider.

19. Service Provider acknowledges that if any of its employees/sub-contractors/agents/representatives are involved in any illegal activities such as malpractice with source of water, tampering with water quality report, tampering with GPS system etc., then such illegal activities shall amount to material breach of the present Contract and the Buyer shall be entitled to avail civil and criminal remedies and shall have discretion to terminate the present Contract with immediate effect.

20. The site for source of water can be inspected by the Buyer at any given time without prior information to Service Provider, and the Service Provider shall assist the Buyer in coordination and getting all necessary inputs/information/documents as required by the Buyer. xxii. Water being essential service, if the Service Provider fails to provide the service in the required standards even after three notices, his/her order may be cancelled and new supply order may be placed for rest of work

21. Any damages caused by the Service Provider in existing facilities while carrying out the work shall be made good by the Service Provider to Buyer's entire satisfaction at their own risk and cost.

22. Service Provider to provide contact details of the officers supervising on behalf of the service provider. A complaint escalation matrix will be provided by Service Provider.

23. Unless specified otherwise by the Buyer, Service Provider shall ensure that water is supplied within 3 (three) hours of intimation.

24. Upon receiving the water supply at its premises, the Buyer shall promptly check the tanker conditions and quality of water supplied at its site. The Buyer shall also notify the Service Provider, as soon as possible after the Buyer becomes aware of any of the following conditions -

I. Any problems, complaints, incidents, or accidents that occur during performance of the services under this contract including any form of inappropriate behaviour by the personnel of the Service Provider.

II. Any dishonest, wrongful, or negligent acts or omissions of its personnel or agents of the Service Provider in connection with the services.

25. The service provider shall supply the water with the chemical components level as indicated below so that it is suitable for chiller plants, medical and general equipment's installed in the premises of the hospital.

Buyer's Obligations

Buyer shall provide contact details of the nodal officer who will be responsible for coordinating the delivery at specified location.

अस्वीकरण/Disclaimer

The Additional Terms and Conditions (ATC) have been incorporated by the Buyer after approval of their Competent Authority. The Buyer is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any restriction arising in the bidding process due to these ATCs and including the modification of technical specifications and / or terms and conditions governing the bid. All representations / grievances pertaining to the ATC clauses shall be raised with the buyer organization directly and not with GeM. If any of the clause(s) is/are incorporated by the Buyer regarding the following, the bid & resultant contract shall be treated as null & void. Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-

1. Publishing Custom / BOQ bids for items for which regular GeM categories are available (unless such Custom / BOQ item is bunched with the major regular product Category Item).
2. Mandating procurement of / from specific Brand / Make / Model / Manufacturer / Dealer except in case of Single Bid / Proprietary Article Certificate (PAC) Buying.
3. Inclusion of disqualification criteria related to suspension of seller / service provider, where such suspension period has already expired.
4. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
5. Publishing bids on GeM for procurement of works.
6. Procurement of Goods by creating a Service bid on GeM & vice-versa.
7. Seeking sample with bid or approval of samples during bid evaluation process. However, trial / sample, as the case may be, shall be permitted in cases where trial / sample are allowed as per approved and published procurement policy of the Buyers' controlling Ministry / Department / State / Public Sector Enterprises Headquarters. If there is any violation of trial / sample clause with regard to approved policy of the Buyers' Ministry / Department / State / Public Sector Enterprises Headquarters, then this is to be determined and redressed by the concerned Buyer Organisation only.
8. Seeking experience from specific organization / department / institute only or from foreign / export experience.
9. Creating bid for items from incorrect categories.
10. Reference of conditions published on any external site or reference to external documents/clauses.
11. Asking for any Tender fee / Bid Participation fee, as the case may be.

12. Buyer added ATC Clauses which are in contravention of clauses defined in bid detail section, including specifications, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by the applicable GeM GTC.
13. Any ATC clause in contravention with GeM GTC Clause 4 (xiii) (h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
14. In a category based bid, adding additional items, through buyer added, additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogues or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.

For all provisions of the Labour Codes that are pending operationalisation through rules, schemes or notifications, the corresponding provisions of the pre-existing labour enactments (such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972, etc. and relevant State Rules) shall continue to remain applicable.

The Seller/ Service Providers shall, therefore, be responsible for ensuring compliance under:

- **All notified and enforceable provisions of the new Labour Codes as mentioned hereinabove; and**
- **All operative provisions of the erstwhile Labour Laws until their complete substitution.**

All obligations relating to wages, social security, safety, working conditions, industrial relations etc. and any other statutory requirements shall be strictly met by the Seller/ Service Provider. Any non-compliance shall constitute a breach of the contract and shall entitle the Buyer to take appropriate action in accordance with the contract and applicable law.

This Bid is governed by the General Terms and Conditions, conditions stipulated in Bid and Service Level Agreement specific to the Service, as the case may be, as provided in the Marketplace.

However, in case of Service, if any condition specified in General Terms and Conditions is contradicted by the conditions stipulated in Service Level Agreement specific to said Service, then it will over-ride the conditions in the General Terms and Conditions.

of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority. While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws.
